AMENDMENT MEMBERSHIP VOTE TO THE GOVERNMENT DOCUMENTS

According to Tim Hendrix, Management, official count of 51 owners' votes were: **25 = YES Votes; 15 = NO Votes (11 Owners did not vote).**

Amendment – FAILED needed 39 Votes to pass.

Giarrizzo confirmed Amendment did not pass. He made a motion to adjourn, second by Hoffman with all in agreement.

<u>Second, Call to Order</u>: Charles Giarrizzo, President, called the 2024 Budget meeting to order at 4:08pm. <u>Quorum</u>: A quorum of the Board was present with Charles Giarrizzo, President, Barbara Hoffman, Vice President & Secretary, John Ricci, Treasurer, via Zoom, and George Alexiou, Director, David Jeroski, Director and Tim Hendrix, Management at Ameri-Tech Office.

<u>Proof of Notice:</u> Hoffman posted Agenda notice on both Bulletin Boards and sent emails to all members.

2024 BUDGET ADOPTION Meeting

VOTE TO WAIVE FINANCIAL REPORTING: According to Hendrix, New Florida Statute Law of July 2023 requires official count vote of 50% +1 needed of those present or by proxy to pass. **24 = YES Votes**; **16 = NO Votes**. **(Passed – 51% needed)**.

VOTE TO WAIVE FULLY FUNDING THE RESERVES: Requires 50% +1 of the entire membership or 26 votes to pass. **24 = YES Votes; 18 = NO Votes.** (Failed – **26 votes needed to pass).**

VOTE TO ROLL OVER EXCESS FUNDING: Requires 50% +1 needed of those present or by proxy to pass. **39 = YES Votes; 2 = NO Votes. (Passed – 51% needed).**

Giarrizzo made the motion to adopt 2024 Proposed Budget with Fully Funding Reserves at \$538,449.00/Annual Budget and \$1129.39/Monthly Maintenance Fee. Hoffman second the motion, which passed with 4 yes votes and 1 no vote from Ricci. 2024 Budget was adopted.

Membership Comments were welcomed. Questions and concerns were answered.

Adjournment: As business was concluded, Giarrizzo made motion to adjourn meeting at 4:26PM, Hoffman second, unanimously passed.
