I move that the Board of Directors approve a Special Assessment for the estimated amount of \$17,080.00/per Unit, totaling an estimated \$871,080.00 for the purpose of reducing the balance of the Flagship Line of Credit, for the Roof and Road Capital improvements collectively referred to as the "PROJECT," and to pay back "PROJECT" costs borrowed from our Reserve Accounts.

Owners will have the option to pay their share in full, or to select a 10year Installment Plan with interest that coincides with the interest accuring on the Flagship loan. The carried balance may then be paid down in part, or in full, at any time during the term of the loan, but in all cases the remaining balance will be "due in full upon sale of their Unit."

Payment Plan: First payment due on September 1, 2023, with Ameri-Tech Management to apply standard accounting principles for collecting Special Assessment funds from owners and will make our single monthly payments to the Flagship Bank loan.
